OCTOBER SEES THE START OF THE POPULATION AND HOUSING CENSUS

HAVE YOU RECEIVED A NOMINATIVE LETTER FROM ISTAT INVITING YOU TO PARTICIPATE IN THE CENSUS?

It means that you are a part of a selected statistical sample, which will have to independently answer to the census: fill out the online survey as soon as possible, by accessing with the credentials you find in the letter.

Starting from the 6th of October 2024, the family may fill in the online form or go in person to one of the Municipal Survey Centers **Centri Comunali di Rilevazione (CCR)** (see the list), where you can be helped by a Municipality officer.

The families who will not fill in the online form or will do it incompletely, will receive a reminder from ISTAT in the second half of October 2024.

The deadline to fill in it is the **9th of December 2024**.

From the 10th of December 2024 families will still be able to answer, but only as follow:

- Phone interview with a municipal officer
- Home interview with a municipal officer, on appointment
- In person interview with a municipal officer operator at one of the Centri Comunali di Rilevazione (CCR).

The survey will close on the **23rd of December 2024**.

Taking part in the Census is a legal obligation.

HOW TO FILL IN THE ONLINE FORM

Once you have entered “fill in the form” portal, click on “log in” (on the left side of the page).

You can access with the **user code** and **PIN*** (it is the fiscal code of the letter receiver) or with the **SPID** or **CIE** credentials.

It means you're a part of a sample participating to the Census 2024 with the support of a municipal officer".

From the 11th of October until the 22nd of November 2024, you will be able to welcome the municipal officer, who will give you the necessary information on the census.

in the advice you will find all information about: the ongoing census, the name of the municipal officer , the date and time of his visit , and all the useful contacts for more information.

Furthermore, you will receive an information letter from ISTAT announcing you the start of the survey, its methods of implementation and the necessary contacts to have assistance and clarifications. In addition, you will

receive a leaflet containing further useful information on the census and on its explorative purposes.

A municipal officer **with a badge** will contact the selected families and, **after collecting some personal information**, will explain the different methods of participation to the census and how to fill in the form.

The families will be able to choose between:

- The municipal officer collecting all the required information of the form, together with you at your home.
- Filling in the form independently on the officer device, with his assistance if needed, at your home.
- An home interview with the municipal forensic officer, who will collect with you on a digital device all the required information on the form.
- Going in person to one of the selected Centri Comunali di Rilevazione to:
 - Conduct the interview with a municipal operator who will digitally collect the required information of the form.
 - Independently fill in the form on a device given by the Municipality, , with the technical assistance of an operator, if needed.
